Budget. No additional budget information has been disseminated since the last Parent Group meeting. Steller is currently at 2.4 FTE per core subject and it would be difficult to lose any teacher due to the breadth of courses taught. Cutting a teacher could really hamper any core program within the school. Program capacity is 291 with a current enrollment of 289. The program could use more students and potentially exceed capacity to help reduce risk of losing an FTE. May need parents to organize and get vocal with phone calls and letters with quick notice.

Self-Direction. Staff is still leaning towards all students having self-directed learning classes third period. Reed has someone interested in supporting this effort and willing to help setup students with outside opportunities. May approach Parent Group for funding next year.
